TOURNAMENT PERIOD

1) 16 (Saturday) to 17 (Sunday) August 2025

TOURNAMENT TIME

2) 9.00 am to 10.00 pm.

TOURNAMENT VENUE

REGISTRATION

- 5) Registration will commence on **24 June 2025 (Tuesday)**.
- 6) Rules & regulations (R&R) are downloadable from: <u>www.stta.org.sg</u>
- 7) Registration shall be done via the registration link from STTA website ONLY.
- 8) Registration by any other method(s) will <u>NOT</u> be accepted.
- 9) Closing date of Registration: 21 July 2025 (Monday) at 12:00 noon.
- 10) Registration fee paid is strictly not refundable including double payment except for the case mentioned below in para 11.
- 11) Any event with less than EIGHT (8) entries will be scrapped and the registration fees will be refunded. However, Organising Committee reserve the right to organize the event with reduction in the prize money if there is a short fall of entries.

ELIGIBILITY OF PLAYERS

12) Only players who have active STTA Individual Memberships (Athlete) are allowed to participate in this tournament. Participants with outstanding dues to STTA must be

cleared by 21 July 2025 (Monday). Otherwise, he/she will not be inclusive for the open draw. There will be no refund of registration fee.

- 13) A player is ONLY permitted to participate in ONE event.
- 14) Women's Singles 35 & Above event are open to players who are <u>born in or before</u> <u>1990</u>.
- 15) Men's Singles 40 & Above event are open to players who are born in or before **1985**.
- 16) Men's Singles 50 & Above event are open to players who are <u>born in or before **1975**</u>.
- 17) Men's Singles 60 & Above event are open to players who are <u>born in or before **1965**</u>.

TOURNAMENT SYSTEM

- 18) All players must report to officials' table at least 30 minutes before the scheduled match. Player shall concede a walkover, if the player is not on court at the scheduled time after the match has been announced on court. There shall <u>not</u> be any grace period.
- 19) In the event a walkover is conceded in a group stage match, a player can still play in the remaining match(es) in his or her group stage with no penalization or deduction of ranking points.

If a player does not appear at all for one event, <u>no penalty points</u> will be imposed on him/her for that event.

- 20) For walkover conceded in the knock-out stages, prize money and placing shall be <u>forfeited</u>, ranking points for the event will be taken away and <u>penalty points</u> <u>imposed</u>. In addition, disciplinary action will also be taken by STTA.
- 21) All events shall be played on either a single knock-out system or group round robin system depending on the number of events and number of entries per event.
- 22) All matches shall be played to the **best of-5-games** of 11 points each.
- 23) This tournament is part of the STTA Table Tennis Masters Series. Ranking points shall be accorded according to the Masters Ranking Policy.
- 24) The tournament shall be run in accordance with the latest rules and regulations of the International Table Tennis Federation (ITTF). Rules and regulations of the ITTF can be downloaded from <u>www.ittf.com</u>.
- 25) The ITTF approved 3-star white balls shall be used during this tournament.
- 26) No **white** apparels (shirt and shorts) are allowed. Players who fail to conform to this dress code will not be allowed to play.
- 27) Each player is allowed to have an accompanying coach who must have active **STTA Individual Membership (Coaches)**, to provide side coaching for their match(es). Proof of valid STTA Individual Membership (Coaches) must be shown to officials upon request. *Please note that processing time for STTA Individual Membership (Coaches) application may take up to 3-4 weeks.*
- 28) Players are not allowed to use mobile devices to make or take calls at all times during their match(es).
- 29) Umpires will be provided for all matches.

FIXTURES

30) The complete entry list shall be published on STTA website from Thursday, 24 July2025 onwards. Any discrepancy or omission of entries must be brought to the

attention of STTA by Wednesday, 30 July 2025. <u>Strictly no changes shall be made</u> <u>after the omission check</u>.

- 31) An open draw of tournament fixtures will be conducted on **5 August 2025** (Tuesday), 7pm at OCBC Arena Hall 6. All are welcome to witness the draw.
- 32) Fixtures with match schedule will be displayed on STTA Website from **7 August 2025** (Thursday).

PRIZE PRESENTATION

- 33) The Prize Presentation Ceremony shall be held immediately after the finals of the events.
- 34) All prize winners <u>MUST</u> be present in person at the ceremony in proper attire (no singlet, slippers and sandals) in order to receive the award/s.
- 35) If prize winners do not turn up during the prize presentation ceremony, their award/s will be forfeited.
- 36) The Organizing Committee reserves the right NOT to award the prize money and trophy if the above-mentioned regulations are not adhered to. In addition, ranking points for the event will be taken away and penalty points will be further imposed. Please refer to Masters Ranking Policy for more information.
