## 1. AUTHORITY

The South East Asian Youth Championships - SEA Regional Qualification to the 30th Asian Youth Championships 2026 will be organized by Singapore Table Tennis Association under the authority granted by the International Table Tennis Federation (ITTF), the Asian Table Tennis Union (ATTU) and South East Asian Table Tennis Association (SEATTA)

**12. RULES**

The event will be conducted in accordance with the current Laws of Table Tennis and the Regulations for International Competitions, as modified or supplemented by this prospectus. The ITTF Ranking Default Policy will also be applied.

**Note:** All players are encouraged to have their names printed on their shirts from the beginning of the event.

All racket coverings must be of a type currently authorised by the ITTF.

**14. ELIGIBILITY**

The event is open to South East Asian Member Associations of ATTU satisfying the following conditions:

- U19: Players born on or after **1 January 2007**
- U15: Players born on or after **1 January 2011**

The ITTF international eligibility regulations 3.8 and 4.2.3 shall apply to all team and individual events.

## 16. ENTRIES

Final entries must be submitted on the **ITTF Entries Management System** by providing all necessary information.

The Entry System will be open from **1 December 2025**

**Final entries deadline is 2 February 2026**

Do note that all players must be registered with ITTF and have a player ID.

In the event that there are new player registrations, do register them with ITTF at least a month before the final entries deadline in order to receive the player ID.

No additional entry shall be allowed after the final entry deadline, only changes or cancellations (modifications) are accepted.

For accompanying persons (doctors, physiotherapist, etc.) please contact the Organizing Committee to confirm the availability of places at the official hotel.

## 19. TRANSPORTATION

- a. The Local Organizing Committee (LOC) shall provide one (1) airport transfer from Changi International Airport upon arrival and one (1) airport transfer to Changi International Airport upon departure, per country only.
- b. Delegations shall submit consolidated travel details to the LOC within the prescribed deadline.
- c. The LOC shall not be responsible for providing additional transfers in cases of split arrivals or departures, incomplete information, or late submission of travel details.
- d. Any transportation requirements beyond the provision stated in Clause 1 shall be the sole responsibility of the respective delegation.

## 20. HOSPITALITY

(Complimentary hospitality will only be extended to 1 official if the MA takes part in all team events)

Same hospitality shall be provided for extra participants/officials at the cost of **USD 195** (+/- SGD 250) per person per day for single room, **USD 140** (+/- SGD 180) per person per day for twin/double room and **USD 95** (+/- SGD120) per person per day for quad room.

The organising committee will provide the reasonable airfare (Economy) for the Technical Delegate and one foreign Deputy Referee.



Each participating country may nominate up to 1 International Umpire and it must be indicated in the Umpire Nomination Form. The umpires will be responsible for their own air fare. Please note that not all nominated umpires will be selected for the competition.

The Organising Committee will provide free hospitality and daily allowance to all foreign International Technical Officials (ITOs) in accordance to ITTF regulations 2026.

## 21. CANCELLATION POLICY

Accommodation cancellation from 27 **March 2026** will be required to pay the full duration of nights booked of respective room rate

## 24. PLAYING SYTEM

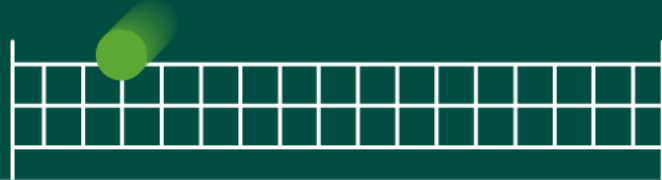
### Team Events

The team competition will be conducted in two (2) stages

#### Stage 1

Teams will be divided into two (2) groups to play a Round Robin System to determine the group winners

#### Stage 2



The top two (2) teams from each group will play a Knockout System to determine the positions of 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup>.

Order of Play      A vs. X, B vs. Y, C vs. Z, A vs. Y, B vs. X

All team matches shall be best of five (5) games.

If the number of participating teams is less than 6, the teams will play a Round Robin System to determine the winners.

### **Singles Events**

The Singles competition will be conducted in two (2) stages.

#### **Stage 1**

Players will be divided into two (2) groups depending on the number of entries to play a Round Robin System to determine the group winners

#### **Stage 2**

The winners from each group from stage 1 will play a Knockout System to determine the winners.

The matches shall be best of five (5) games, except Semi-Finals and Finals matches shall be best of seven (7) games.

### **Doubles Events**

All doubles events to be played in a Knockout System to determine the winners.

All double matches shall be best of five (5) games.

One player is entitled to participate in only one age group for each event.

## **25. SEEDINGS**

Seeding for team and individual events shall be based on the results of **2025 South East Asian Regional Qualification Tournament to the 29th Asian Youth Championships 2025**

In the event teams or players not included in the result list, the latest ITTF ranking shall be taken into consideration.

The seeding list shall be furnished by the SEATTA Technical Committee Chairman who shall advise the Organizing Committee on the preparation for the draw.

## 26. MATCH OFFICIALS

All matches will be officiated by qualified umpires in accordance with the directives for Match Officials at World Title Competitions

## 27. OBLIGATIONS

The entry will contain a statement that players nominated are willing to compete against any other participating player or team and that the participants respect and acknowledge regulations and rules of the ITTF Handbook. This statement must be confirmed by a responsible official of the nominating





Member Association and no entry form will be accepted unless such an undertaking has been given.

## 28. LIABILITY

A. By entering the tournament, participants agree to abide by all ITTF and ATTU rules and by the rules and regulations of the LOC. All entered associations and players agree to be under the auspices of the ATTU and ITTF and its agents in all matters concerning television coverage, video, internet web casting, motion picture coverage, and photographic coverage of any kind.

B. Participants release all rights, or rights held by their agents or sponsors, in all matters relating to television and web casting coverage, video and motion picture coverage, and photographic coverage of any kind. A participant's refusal of above listed coverage may be subject to suspension or dismissal from the competition.

C. Any participant, when called upon, must appear promptly to press conferences or medal presentations and follow the procedures set by the ATTU and the LOC.

D. By entering the tournament, each Association must ensure that all delegation members confirm that they know that their personal data will be shared with the LOC, SEATTA, ATTU and ITTF who, in turn, undertake not to share it with any unauthorized person in any way.

E. In the context of betting, participants in the event shall follow the ITTF Code of Ethics (Chapter 6 of the ITTF Statues). They shall not, by any manner whatsoever, infringe the principle of fair play, show unsporting conduct, or attempt to influence the course or result of a competition, or any part thereof, in a manner contrary to sporting ethics. Any violation of this principle shall be disciplined according to provisions of ITTF regulation 3.5.3.

F. By entering the tournament, all delegation members undertake to abide by the ITTF's anti-doping rules and Anti-Harassment Policy and Procedure (Chapters 5 and 7 of the ITTF Statues).

G. By entering the event, each association must ensure that all delegation members have medical, travel and other appropriate insurance for the duration of the event.
